TERMS AND CONDITIONS :

- Lebowa Funerals Traditional Funeral Scheme has (3) three affordable options of funeral covers to choose from.
- There is no joining fee for all options. (No Medical Examination is required when joining)
- The minimum entry age of the policyholder is (18) eighteen years and the maximum entry is (74) seventy four years.
- The maximum entry age for extended members is (84) eighty-four years.
- Collections, deliveries and burial transport is free for **600km radius**. If the radius is more than **600km**; there will be a fee of **R 5.00** per kilometre that will be charged.
- There is no waiting period for accidental death.
- There is a waiting period of (3) three months for death due to natural causes.
- No claim will be honoured if death occurs during the waiting period.
- For death due to suicide; waiting period is a (24) twenty four months.
- All premiums must be paid before the (7th) seventh of every month. Premiums are to be paid a month in advance. Premiums can be paid at LFP offices; retail stores and through stop/debit order.
- The Traditional funeral scheme is provided on a month to month basis and therefore there are no surrender value if the cover lapses. No reinstatement for lapsed funeral schemes.
- The funeral scheme lapses after the (7th) seventh of the third month. Claims will not be honoured (if is not claimed within (3) three months of death of any person covered under your funeral scheme.
- If premiums are in arrears; then no claim shall be honoured.
- Premiums are required to secure a member's benefits and shall be payable from the commencement date of the funeral scheme.
- Documents required for joining:** ID copies of adult members and children's birth certificates.
- Documents required for claiming:** Certified ID copies of the deceased and beneficiary; certified copy of death certificate; BI 1663; original funeral scheme booklet/funeral scheme card/ or (3) months bank statement if policy is paid through stop/debit order.
- Benefits claimed will be transferred **within 48 hours** into the policy holder's/ beneficiary's bank account.
